### General conditions of advertising on the website www.boatsforsale.eu



- WWW.BOATSFORSALE.EU is a website operated by a natural person Branislav Šťastný BRAST, ID 34973176 hereinafter referred to as the operator.
- The operator of the portal WWW.BOATSFORSALE.EU is not responsible for the content of published advertisements, including text and photos.
- User data WWW.BOATSFORSALE.EU will be used by the operator only within the limits of the law.
- The operator acts as an intermediary between the supply side and the demand side, but is not responsible for the business itself product quality, delivery, payment, copyright infringement, etc.
- The operator is not responsible for the misuse of data published in advertisers' offers by third parties.
- The operator has the right to change, innovate and otherwise modify the services of the portal WWW.BOATSFORSALE.EU without the prior consent of advertisers.
- The operator has the right to change, modify or supplement incomplete or incorrect information in advertisements or registrations without the prior consent of advertisers.
- The operator reserves the right to occasionally send a newsletter or other information or promotional e-mail.
- The operator reserves the right to export advertisements to partner portals such as. WWW.BOAT24.CO.NZ, WWW.BOAT24.COM.AU and others.

# **Cancellation of registration:**

Cancellation of registration is possible according to current GDPR laws in force in the Slovak Republic

#### Is forbidden:

- Inserting advertisements that violate the laws of the Slovak Republic, such cases are reported to the police, to whom we give documents for the search for the perpetrator (sale of TP, service books, labels, handling of mh / km ...).
- Post ads that are contrary to good behavior.
- Create duplicate advertisements, fictitious advertisements and advertisements created for the purpose of buyer fraud (eg send a deposit in advance, "phishing" ...).
- Create duplicate registrations, the given accesses will be combined into one.
- All information about the ad must be available directly from the text of the ad, it is forbidden to enter ads of the type "for more information write to e-mail ...".
- Delete or enter false contact information during registration as well as subsequently in the user's profile (eg fictitious or non-existent phone number), the given accesses will be deleted without notice
- Inserting ads in categories other than where they belong, these ads are deleted (or moved by the administrator).
- Inserting advertisements listed with an unrealistic price, or with the indication "price by agreement", these advertisements will be deleted. The amount on the advertisements must be final without additional fees (registration, commission, transcript, import ...).
- Ships and other advertisements intended for import, ie not located with the advertiser, must be clearly marked in the status "For import-order". Ships not registered or if the price of the vehicle does not include the cost of registration, it must be properly marked in the condition of the vehicle as 'unregistered'.
- Enter a price other than the total price when paying in cash. The price in case of refinancing can be stated in the note, but not as the main price of the advertisement.
- Indicate the price without VAT. All prices must include VAT! If it is possible to deduct VAT, this is indicated by ticking the appropriate box.
- Indicate the final price as the price of the down payment or one / first installment when continuing the lease or in other installments. The price for the continuation of leasing or other installments must be stated as the sum of all installments, including the advance payment, by filling in the appropriate fields of severance pay, amount and number of installments.
- Insert contact information (e-mails, phones, mobile phones, www) and price data into the text of the advertisement, these data are filtered. Separate fields in each user's profile are used to provide contact information and prices

- Insert commercial advertising (promotion of companies, sole traders, services, etc.), for example, the seller can advertise his goods only individually, which means that he can not place a single advertisement of the type "wide selection ....... can be found on XYZ Boats. . "
- When creating an advertisement, enter a data other than tech in the Type field. type, other additions of the type "data on KW, 1st owner, full service, leather, quick deal, TIP TOP, super boat, 8 seats, cheap, by agreement, possible exchange, etc. will be removed without notice.
- Inserting advertising photos for another or similar type of goods or services and unrealistic photos (copied photos from other advertisements or from other advertisers), these photos will be deleted.
- Advertise a service or your gainful activity, for this purpose you can rent an advertising banner from us
- Edit photos to insert various text or graphic labels, vendor logos, or other highlights or borders. These adjustments are taken as an additional paid service.
- Use one ad to offer multiple items at once, or by gradually exchanging photos and changing the content of the ad. Each ad offers one specific item, or a set of items that are sold as a whole, not separately. This does not apply to the sale of ships to ND.
- Use derogatory, vulgar or aggressive terms in the description or other text of the advertisement or in communication with interested parties or employees of the operator, whether electronic or verbal.
- Delete and then add the same ad to appear in the latest offers. We accept this only after 4 weeks. By violating this rule, we reserve the right not to publish advertisements in the latest offers.

## Advertising rules for private advertisers:

- I. A private advertiser is a natural person selling his private property.
- II. To actively use advertising services, a private advertiser must register on the portal WWW.BOATSFORSALE.EU, on the basis of which the service is immediately available to him. Registration is done by filling out an online registration form for private advertisers. The information provided in the registration form must be true and current.
- III. One-time private advertising with photos is free. There is a fee for the use of paid advertising, heating, framing of the advertisement, marking ... the amount according to the current price list. Other ads for private advertising are free of charge in a maximum of 5 ads per year. Of course, even paid advertising must follow the rules of advertising. Please do not use the phrase "I paid, I can do what I want now" at all, it could end in blocking the account.

- VII. By registering in the WWW.BOATSFORSALE.EU system, the private advertiser agrees to the publication of his own contacts (which he determines himself) in his offers. By registering on the WWW.BOATSFORSALE.EU system, the private advertiser agrees to the publication of his own contacts, which he will state during registration in order to be listed together with the offer of the private advertiser. At the same time, the private advertiser expressly agrees with the above registration that the operator, within the framework of creating a system of rules ensuring the comfort of private advertisers, may provide telephone contact information to the private advertiser for a fee at the operator's discretion. - X. WWW.BOATSFORSALE.EU reserves the right to lock the profile data when the account is blocked, due to intentional modification for further violation of the rules. In case of profile change or deletion, it is necessary to contact us.
- XI. The private advertiser has the right to subscribe to the number of credits that he has the right to use to place private advertisements in the environment of the WWW.BOATSFORSALE.EU portal in accordance with the rules according to these general terms and conditions. If the seller does not want to be included in the section "SELLERS AND SERVICES", his advertisement will be charged in the same way as for private advertising.
- II. The seller is fully responsible for the content of its own published offers (advertisements), including text and photos. When adding an offer, the seller is obliged to ensure that its content is in accordance with the legislative standards of the Slovak Republic, in particular:
  - may advertise only items whose sale is permitted in the Slovak Republic and their acquisition was in accordance with the laws of the Slovak Republic
  - is obliged to modify the content of its own offer so that it does not interfere with the rights of other private advertisers and sellers and in no way disparages their good name, damage national, ethnic or religious feelings and is in accordance with the Act on the State Language of the Slovak Republic
  - may not offer in its own offer other products or services than those directly related to the offer
  - may not publish the same tender several times if the original tender is still valid
  - must always advertise a specific product, not its business as a whole, except in the case of paid advertising products, especially banner advertising
  - is responsible for the truthfulness and timeliness of all personal data provided.
  - By registering on the WWW.BOATSFORSALE.EU portal, the Seller agrees to the publication of his own contacts (which he determines himself) and identification data (company name and address) in his offers.
  - By registering, Seller agrees that the services of WWW.BOATSFORSALE.EU may include the linking of advertising to other sites cooperating with WWW.BOATSFORSALE.EU
  - The Operator is not obliged to ensure the publication of the offer by a system other than the standard on WWW.BOATSFORSALE.EU and is under the full responsibility of the advertiser
  - The Operator reserves the right to change or delete advertisements (or the entire account!), which:

    □ have been assigned to the wrong category.
